Fire and explosion conditions : Vapor concentrations in enclosed areas may ignite explosively. Product may ignite if heated in excess of its flash point. Vapors may travel to sources of ignition and flashback. Closed container, may burst when exposed to extreme heat. Empty containers may contain ignitable vapors.

**SECTION 6 - SPILLS / LEAKS / ACCIDENTAL RELEASE MEASURES**

Use appropriate protective equipment. Avoid contact with material. Remove sources of ignition immediately. Stop flow of material if safe to do so. Contain spill and keep out of water courses. Ventilate area.

**SECTION 7 - HANDLING AND STORAGE**

To prevent generation of static discharges, use bonding/grounding connection when pouring liquid. Extinguish all ignition sources including pilot lights, non-explosion proof motors and electrical equipment until vapors dissipate. Personal protective equipment must be worn during maintenance or repair of contaminated mixer, reactor, or other equipment. Keep container closed when not in use. Vapor may migrate to sources of ignition. Do not smoke, weld, generate sparks, or use flame near container. Store in sealed containers in a cool, dry, ventilated warehouse location.
